POLITICAL PARTIES AND ALLIANCES OF POLITICAL PARTIES START PRESENTING SHORTLISTS FOR POLLING STATION BOARDS (PSB)

Activity number 18 of the electoral calendar, published in the official daily The Gazette of the 11th of May 2021, establishes 30th of September as the starting date for the presentation of short lists, by the Political parties and alliances of political parties, this to integrate the PTB. It also establishes 7th of October as the closing date for completing this process.

FUNCTION AND ATRIBUTES OF THE PSB

Electoral Law 331, chapter 4, in articles 24 and 28, establishes the structure as well as the function and attributes of the PSB.

In particular, the attributes of the members of the PSB on election day, in accordance with Article 28 of the Electoral Law, are as follows:



Verify the credentials of their members as well as those of prosecutors and auxiliaries accredited to the PSB.

Guarantee the working rights of the prosecutors of the participant political parties and alliances at all moments during the process in which they participate in the PSB.

Verify that citizens are registered in the corresponding Definitive List of the Electoral Roll, or qualify the inscriptions of citizens according to the requirements of law and approve said inscription if accepted.

Guarantee the exercise of suffrage.

Guarantee that the votes are deposited in the correct urn.

Undertake the scrutiny of the votes.

Guarantee order in the corresponding electoral district during the electoral process.



- Receive and remit appeals and complaints to the Municipal Electoral Council in accordance with the Electoral Law.
- Permit the access of dully accredited electoral escorts to the polling stations.
- Compose the electoral file after scrutiny of each vote.
- Following the period of scrutiny, constitute the sealed electoral bag.
- Post the election results on a notice board outside the PSB.
- Take the act of scrutiny to the Municipal Center of Transmission for its transmission to the SEC.
- Following transmission of the tally sheet, transfer the electoral bag and the electoral file to the Municipal Computing Center.



SEC AND THE ATTORNEY FOR THE DEFENSE OF HUMAN RIGHTS (ADHR) SIGN JOINT AGREEMENT FOR 2021 GENERAL ELECTION

Apropos the 2021 general election to be realized on the 7th of November, in response to a request from the Attorney for the Defense of Human Rights (ADHR), the SEC and the ADHR signed a joint agreement for the accompaniment of Electoral Attorneys.



Giving its long experiences with electoral processes, the ADHR will provide social support and advise to the citizens in the 3,106 polling stations which have been enabled for the general elections on the 7th of November.



In this context, "the presence of the attorneys will be a guarantee of a culture of ethics, respect, transparency and peace" stated the SEC president Brenda Rocha.

In her intervention, attorney for the defense of human rights, Darling Rios, stated that this organism "celebrates and accompanies this democratic process that guarantees the right to vote, which is for us a commitment and great satisfaction to be able to undertake this accompaniment throughout the country".

The accompaniment of electoral attorneys has the principal objective of promoting, among all actors in the election, a culture of quality, ethics and transparency in each phase of the electoral process.

In the same way, insofar as the citizens exercise of their political rights is concerned, the ADHR will produce an integral report on the different elements of the electoral process in order to offer an objective, impartial input as to the quality, guarantee, protection of and respect for human rights.

8th of october last day for Accreditation of Electoral Prosecutors

In accordance with the electoral calendal, the participant political parties have until the 8th of October to request of the SEC the accreditation of their prosecutors for each one of their PSB throughout the country.

In compliance with article 29, paragraph 2 of electoral law 331, the SEC provided initial training for all legal representatives and technical personal of the parties and alliances of parties, in the use a new digital platform for the register and accreditation of the prosecutors, and for the presentation of the shortlists of members of PSB.

The organizations participating in this electoral process will accredit online more than 190 thousand citizens in order to fully oversee the electoral activity, without any limitations and in accordance with that established in our electoral law.





This SEC, through the General Direction of Information Technology and the General Direction Support to Political Parties, makes itself permanently available to all political parties and alliances of political parties, providing the support needed for the correct use of this IT tool, thus facilitating the online identification of their prosecutors.

The accreditation of prosecutors must obey the principal of gender equity and alternation, guarantying 50% women and 50% men in the list of prosecutors for each party and political alliance.

The SEC reaffirms its commitment to continue strengthening democracy, peace and tranquility, working constantly to guarantee a free, just and transparent electoral process.
