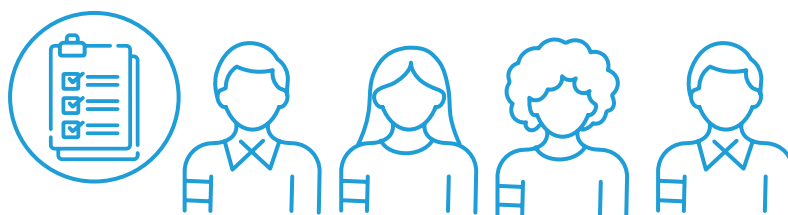

SEC publishes final list of Candidates for the integration of the Regional Councils

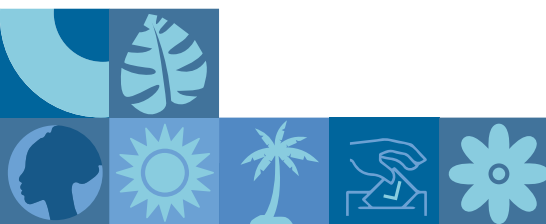
The Supreme Electoral Council, in compliance with article 70 of Law No. 331, Electoral Law, and with Activity No. 12 of the Electoral Calendar, announced through the Gazette, Official Diary, No. 21 of Monday, February 5 of the current year, the final list of Candidates for the integration of the Regional Councils, who will participate in these Regional Elections of the Caribbean Coast of Nicaragua.



In that sense, prior to the publication of the official list of Candidates for the integration of the Regional Councils, in compliance with article 70 of Law No. 331, Electoral Law and Activity No. 9 of the Electoral Calendar, this State Power from January 23 to 29, guaranteed political organizations the period of Correction, Resignations and Substitution of candidates for the integration of the Regional Councils.



Likewise, this electoral institution, from February 2 to 4, fully complied with the development of the period for political organizations to request challenges; and later, on February 5, issuing any resolution in this regard. All of the above, in full accordance with the Political



Constitution of the Republic of Nicaragua and the Electoral Calendar of these "Victorious Elections Caribbean 2024"

The citizens of the Autonomous Regions of the Caribbean Coast will elect the 180 Members of the Regional Councils, among Owners and Alternates, who will make up the Regional Councils of the 30 Electoral Districts, 15 Electoral Districts on the Northern Caribbean Coast, and 15 Electoral Districts on the Southern Caribbean Coast.

This Power of State guarantees compliance with Gender Equity and the concept of Alternation in the list of candidates for the 2024 Regional Elections which is established in article 153 of Law No. 331, Electoral Law, which mandates equal participation fifty percent (50%) of women and fifty percent (50%) of men, to be elected for elective positions.

Beginning of Electoral Campaign for the 2024 Regional Elections

The Supreme Electoral Council guarantees the Political Parties and Alliances of Political Parties the development of the Electoral Campaign period, which began on February 9 and ends on February 28, thus complying with article 74 of Law No. 331, Electoral Law and Activity No. 23 of the Electoral Calendar.

The Electoral Ethics Regulation regulates the 2024 Regional Elections Campaign, which establishes the ethical standards and democratic principles that must be complied with by Political Organizations, natural and legal persons that are participants in this democratic process.



In this sense, the Supreme Electoral Council ratifies that, in this electoral campaign, the media, directors, social communicators, presenters of communication programs in any of its modalities, officials of the Electoral Power, authorities and citizens in general are subject to the Electoral Ethics Regulations.

Through compliance with electoral regulations and the laws established in the Political Constitution of the Republic, the development of an Electoral Campaign in an environment of peace, tranquility and tolerance is guaranteed in the Regional Elections this 3rd of March.

Security in the “Victorious Elections Caribbean 2024”

Representatives of the Supreme Electoral Council, Government authorities, members of the National Police, in the context of the security of the 2024 Regional Elections, held a working meeting with the head of Operations and Plans of the Nicaraguan Army, Carlos Eduardo Duarte; heads of the Air Force, Naval Force and Military Units, during 1st of February of the current year.



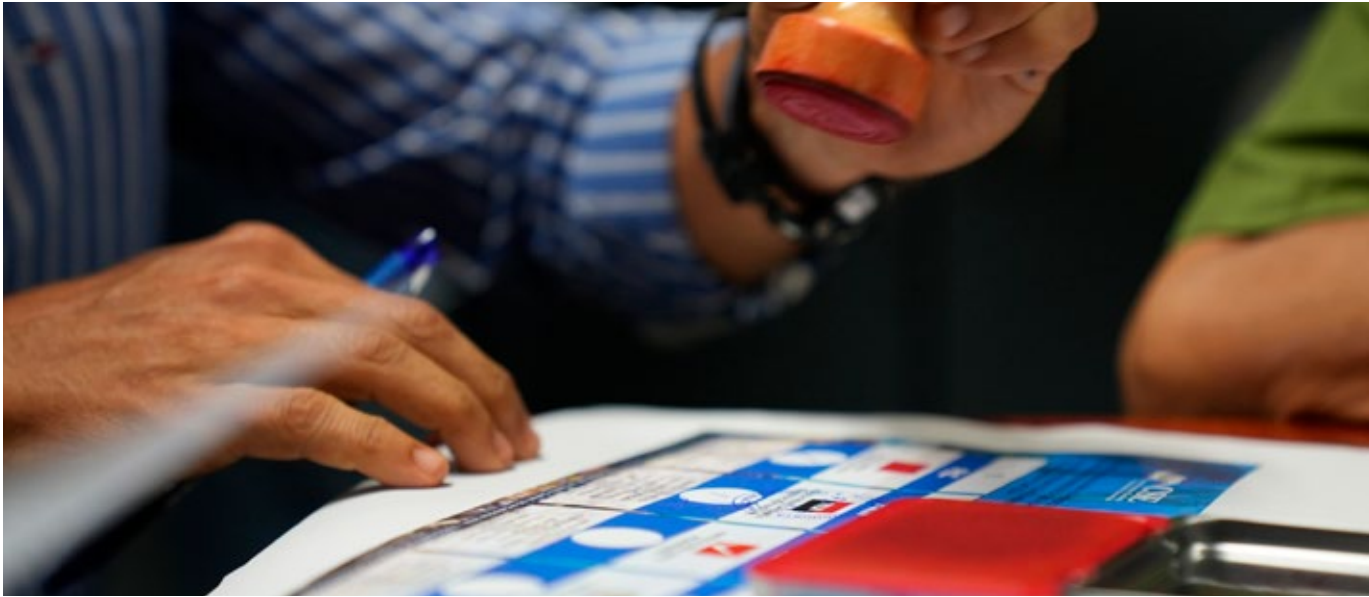


The Brigadier General, Carlos Eduardo Duarte, stated that forces and supporting means will be available to support the Supreme Electoral Council to contribute to the security conditions and transportation of Electoral Material in order to guarantee the proper development of the Victorious Caribbean 2024 Elections to be held on Next 3rd of March.

The Supreme Electoral Council works in coordination with different institutions in the country, ensuring its commitment to continue strengthening democracy and guaranteeing that the citizens of the Autonomous Regions of the Northern and Southern Caribbean Coast exercise their right to vote.

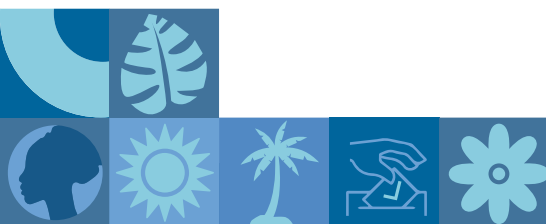


Political Organizations approve the Electoral Ballot of the 2024 Regional Elections



On February 9 of the current year, the Legal Representatives of the Political Parties and Alliances of Political Parties participating in the 2024 Regional Elections to be held this coming March 3, approved the Official Electoral Ballot to be used in the "Victorious Elections Caribbean 2024".

The Legal Representatives of the Political Parties and Alliances of Political Parties were summoned by the Supreme Electoral Council, through the General Directorate of Attention to Political Parties to review the Electoral Ballot and ensure that, in its content, the information of their organizations policies, colors of their flags, acronyms and Candidates corresponds to the information provided by the Political Parties or Alliances of Political Parties participating in this electoral process.



What does the Electoral Ballot contain?

The Electoral Ballot contains the official logo of the Supreme Electoral Council, the name and Number of the Constituency, box number, acronyms, names and flag of the Political Party or Political Party Alliance, as well as the names, surnames, position of the Candidate and whether it is Property or Substitution.

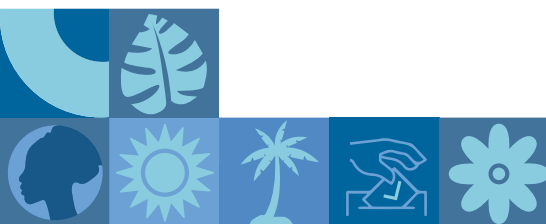
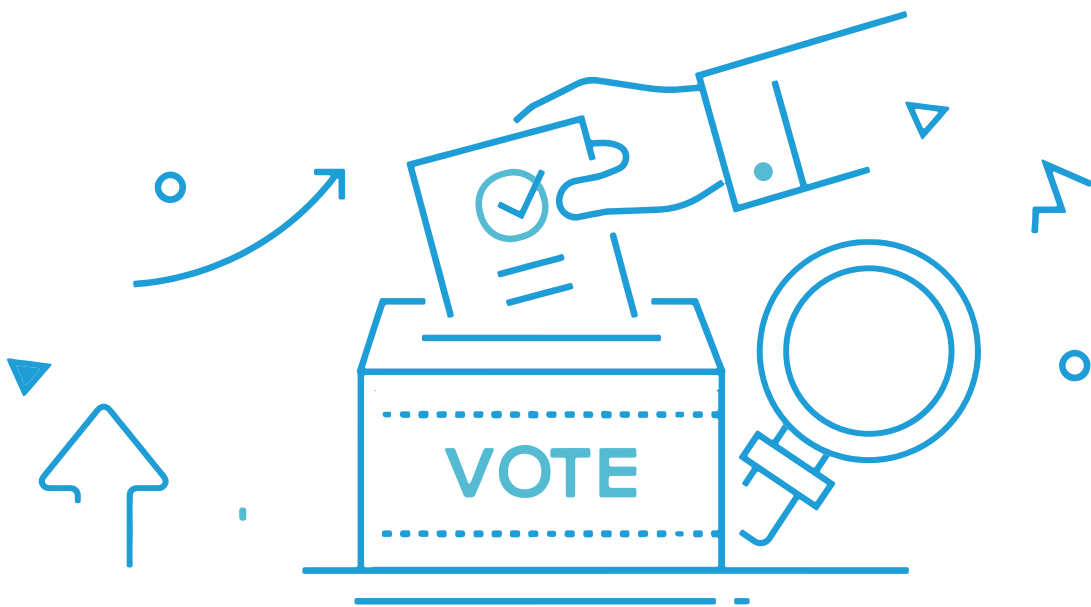
Other essential details that the Electoral Ballot shows are related to the security and authenticity measures that corroborate its issuance by the Supreme Electoral Council, which guarantees peace of mind among all participants.

The official sample of the Electoral Ballot of the "Victorious Elections Caribbean 2024", once each of the elements that correspond to each box had been verified and verified, was signed and sealed by



all the Legal Representatives of the Political Parties and Alliances of Political Parties, thus leaving evidence of their approval.

Having been approved by the Political Parties and Alliances of Political Parties, the Electoral Ballot to be used in these 2024 Regional Elections, this Power of State will begin the printing of the Electoral Ballot, since there was no objection from the Political Organizations, in accordance with what is mandated by Law No. 331, Electoral Law, to continue guaranteeing a Free, Fair and Transparent Electoral Process for all citizens of the Native Indigenous Peoples and Afro-descendants of the Caribbean Coast of the country.
