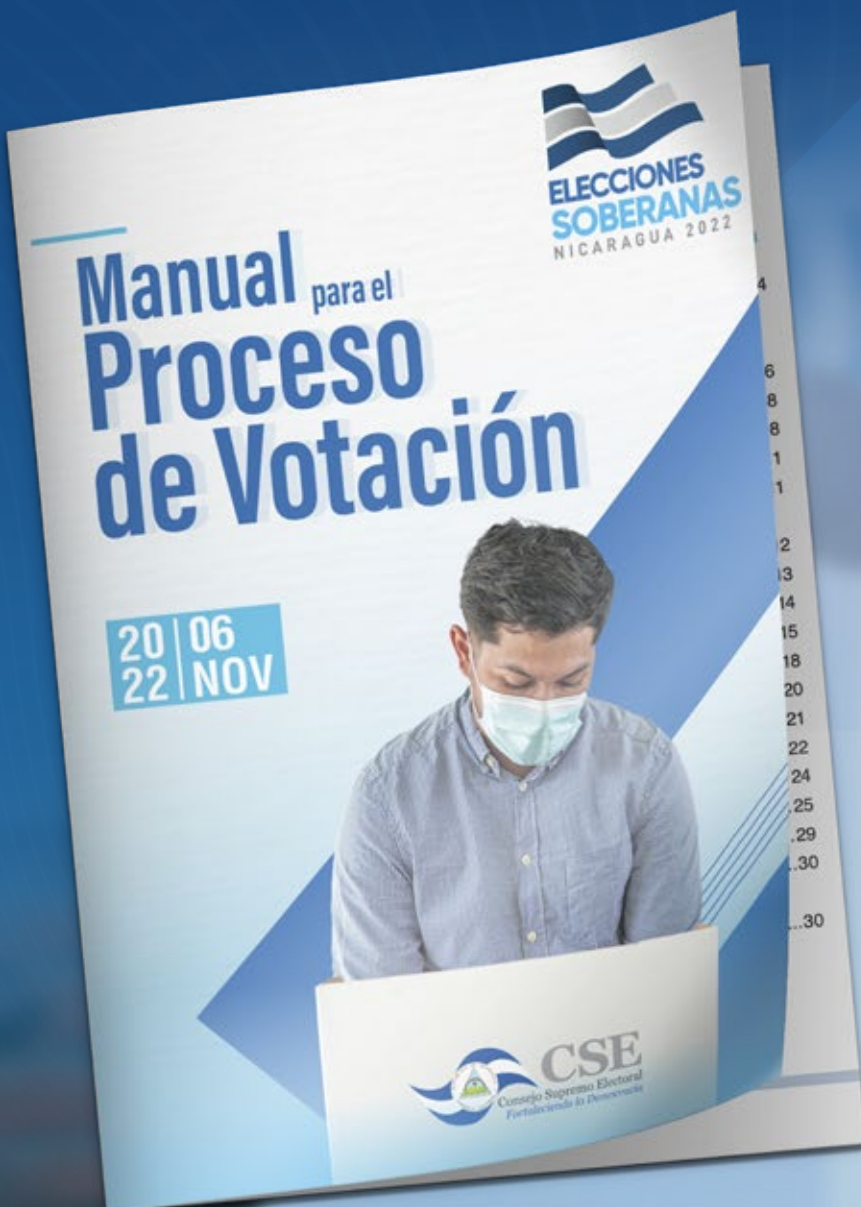

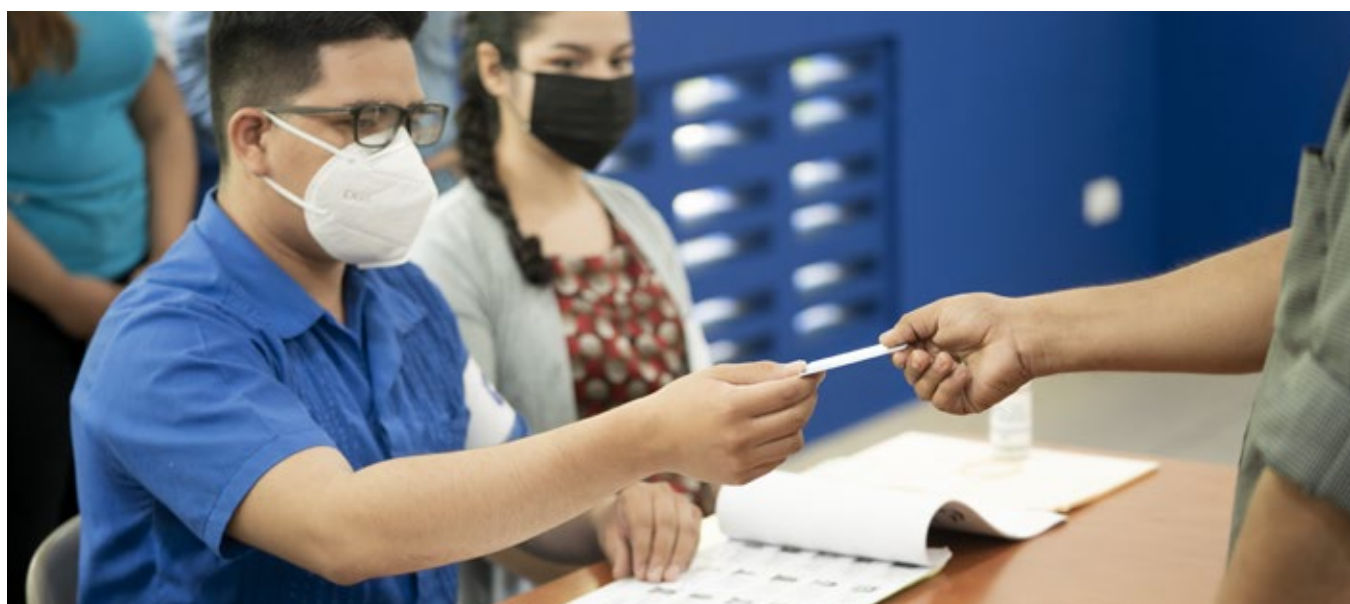

SEC approves Manual for the Voting Process for Municipal Elections 2022



The Supreme Electoral Council (SEC) of Nicaragua officially approved the Manual for the Voting Process of the Municipal Elections 2022, which details the functions and technical procedures that must be fulfilled before, during and after these Elections.

All of the above, attached to article 173 of the Political Constitution of the Republic of Nicaragua; and articles 2 and 10 of Law No. 331, Electoral Law.



It should be noted that this Manual specifies and guides the functions of the Members of the Vote Receiving Boards (VRB), in each of the Voting Centers (VC). Likewise, it describes the appropriate use of substantive and complementary documents and resources, for the exercise of the vote and other related processes.

It is important to emphasize that the Manual contains illustrative images that facilitate the guide and steps of the Electoral Process, as well as a Workbook, which contains the formats that will be available at the Electoral Tables. All this, with the objective that the Members of the Voting Receiving Boards, take ownership of the Voting Process through the practice of these instructions.

This Electoral Power, making use of the New Information and Communication Technologies (ICT), provides the Members of the Vote Receiving Boards (JRV), personnel appointed to perform their functions in the Voting Centers and to Nicaraguans, the Manual for the Voting Process, on its website www.cse.gob.ni

The Supreme Electoral Council of Nicaragua reaffirms its commitment to continue strengthening democracy, peace and stability; working to guarantee all Nicaraguans a Free, Fair and Transparent Electoral Process.



Training for Electoral Police throughout the country



The Nicaraguan Ministry of the Interior, through the Supreme Electoral Council (SEC) and the National Police, trained more than 18,000 citizens who will serve the country as Electoral Police in the 2022 Municipal Elections.

All of the above is in compliance with article 176 of Law No. 331, Electoral Law.

In this sense, this Electoral Power prepared and delivered the Instructions of the Electoral Police, in which the specific and ge-

neral functions of those who will assume this responsibility are established.

In this way, full compliance with the exercise of the functions of the Electoral Police is guaranteed, who will ensure an orderly Electoral Process, in peace, justice and peaceful coexistence.

It is important to emphasize that on October 3, 2022, the Ministry of the Interior, in accordance with Nicaraguan laws, called for the registration of citizens who aspire to serve as Electoral Police, in the Municipal Elections to be held on November 6.

This Power of the State once again reaffirms its commitment to always continue working to guarantee a Safe, Free, Fair and Transparent Electoral Process for all Nicaraguans.



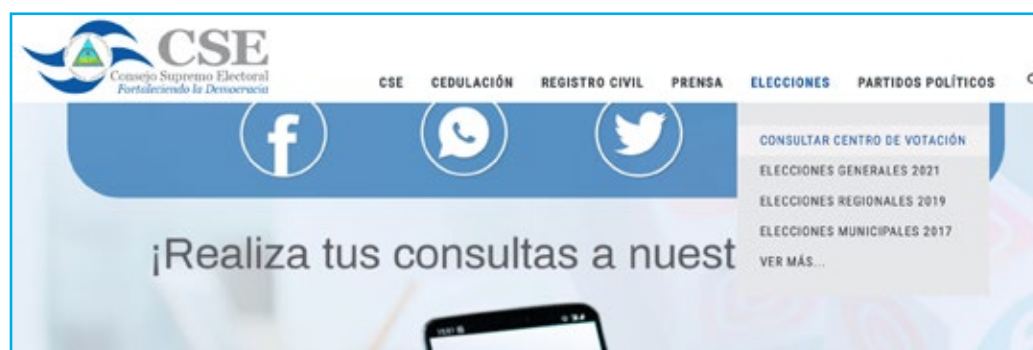


Consult the Voting Center where you will exercise your Right to Vote

The Supreme Electoral Council of Nicaragua, in use of the New Information and Communication Technologies, has permanently facilitated the new digital platform, where all Nicaraguans can consult the Voting Center where it corresponds to them to exercise their Right to Vote, this next November 06.

These are the steps to follow to consult the Voting Center of the Municipal Elections 2022:

1. Go to the website of the Supreme Electoral Council: www.cse.gob.ni
2. Select the Elections menu and choose the option Consult Voting Center
